Name the Walworth County Food and Diaper Bank as the Beneficiary of a Life Insurance Policy

 Naming the Food Bank as a Beneficiary can have positive tax benefits to include enabling you to deduct any premiums paid on that policy to date or in the future.


Name the Walworth County Food and Diaper Bank as the Beneficiary of a Retirement Plan

 Many of us retire with several IRA or 401K plans acquired from various terms of employment throughout our careers. Often these represent funds we do not truly need to maintain our lifestyles. It is simple to contact your Plan Administrator and designate the Food Bank as the beneficiary of the plan. The plan benefit may prove to be a tax deductible gift.

Establish a Charitable Gift Annuity

 Receive and retain the generous income which the Annuity will generate for your lifetime with the remaining value of the Annuity being a gift to the Food Bank. Herein, the projected value of the concluding gift could be immediately tax deductible.

Who we are and what we do

The Walworth County Food and Diaper Bank is a not for profit charity serving the people of Walworth County Wisconsin. This is a volunteer driven organization which relies entirely on private funding. The Charity does not receive operating funds from any County, State, Municipal or Federal Government.

According to the American Community Survey, 12,674 Walworth County Residents live in poverty each day. As the income gap in America continues to accelerate, local poverty, however subtle and often obscure, is and will become one of the greatest challenges to our society. While some poverty in our county is temporary or transitional, most is systemic and continual. It occurs in seniors who no longer can work sustainably and who must rely forever on a meager pension and/or social security, mentally and physically handicapped individuals whose options will always remain limited, those suffering from long term illnesses and families whose capabilities will never generate an income level which can accommodate the accelerating cost of living.

Our Mission is to provide individuals and families nutritional supplemental food, diapers, feminine hygiene and other supplies during a time of crisis, in a cheerful, welcoming, nonjudgmental environment without regard to age, race, creed, color, national origin, physical or developmental disability. We envision a community where everyone has access to sufficient, nutritious food. We believe that access to nutritious food is a basic human right. We are committed to responding to the needs of our community through food distribution and support services.

In addition to providing food directly to individuals and families in need, we distribute food to local food pantries in the county. We act as a redistribution point for the US Department of Agriculture, Feeding America and other food providers. We also supply food to local charities who serve meals. This includes local shelters, camps, schools and churches offering community meals to the public.

Some Statistics

- We directly serve families representing approximately 1,500 individuals per month
- We will collect, process and distribute over 800,000 pounds of food in 2019
- In 2019 we will have acquired over 75,000 diapers for local distribution
- We have no full-time employees and are powered by approximately 60 dedicated volunteers collectively logging over 13,000 volunteer hours per year
- We maintain a 7,000 Square Foot facility with over 600 Square Feet of cooler and freezer capacity
